We have a small management team. While our business plan was intentionally designed to leverage the knowledge and power of our large number of contract producers, we also depend on the skills and experience of a small management team, and notably Nat Mundel, the current sole voting stockholder of the company.

We have taken on the Covid-related SBA EIDL and an automobile loan. These loans bear interest and are required to be paid.

Future fundraising may affect the rights of investors. In order to expand, the company might raise funds again in the future, either by offerings of securities or through borrowing from banks or other sources. The terms of future capital-raising, such as loan agreements, may include covenants that give creditors greater rights over the financial resources of the company.

Our revenue streams are intentionally diversified, and while our economic model and forecasting doesn't rely on our movies and shows being hits or home runs, we still could be impacted by our movies/shows being less successful. While we are not reliant on production fees, and while podcasts are 'covid-friendly' in terms of production, Covid-19 could limit our ability to produce and distribute the films and shows that come from our platform.

We have historically low cost to acquire customers. If that cost increased significantly, we'd have to find different ways of attracting clients.

Does anyone want our services or our film/TV projects and will they pay enough for it? We will only succeed (and you will only make money) if there is sufficient demand for our offerings and projects. Consumers must think we are a better option than competitor products and priced at a level that allows the company to make a profit and still attract business.

We have a number of competitors. There are already companies actively providing services to consumers in our target markets (e.g., Legion M, The Black List, Slated, Stage 32, etc.). While these companies may not provide the same or even similar services, they may be able to provide services that achieve similar benefits to consumers at a lower price.

The shares in this offering are non-voting. Investors in this offering will be acquiring non-voting shares of our stock. This means investors will not have the opportunity to direct the policies of the company through the election of directors. Where certain matters do require votes of investors, that right to vote will be granted to the company's President pursuant to a voting proxy that is part of our subscription agreement.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$200,000**

Use of Proceeds: 25% toward marketing, 25% toward tech/app build, 25% 18.5% toward cash reserves and 6.5% toward Wefunder fee.

If we raise: **\$2,000,000**

Use of Proceeds: 35% toward marketing, 20% toward key hires, 15% toward tech/app build, 10% toward film/TV project development, 13.5% toward cash reserves & 6.5% toward Wefunder fee.

The proxy and power granted by the Subscriber 9 pursuant to this Section are coupled with an interest. Such proxy and power will be irrevocable. The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. We democratize access to Hollywood! Our platform connects storytellers and A-list producers with a listening audience to incubate film, television and podcast content. We've so far produced 8 films and TV shows (including an Emmy-winner!), 9 audio drama podcasts, executed over 280 deals, and a never ending supply of stories in a thriving pipeline of curation and monetization.

By claiming a share of the over \$2.6 trillion Entertainment & Media industry, and making a massive contribution to the 'creator economy', we believe that Voyage can create a business worth over \$200-\$300 million in 5 years if we reach our objectives of producing 12 movies, 104 television episodes, & 600 podcast episodes per year; achieve an audience of ~100 million, and reach profits of ~\$20M on revenues of ~\$60M. Forward-looking projections cannot be guaranteed.

We believe that by disrupting the front end of the content supply chain and building an audience network of 100 million, we are a likely strategic partner/acquisition target for a streaming platform like Amazon, Netflix, Google, or Spotify.

Voyage Media, Inc. was incorporated in the State of California in January 2004.

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$1,522,418 compared to the year ended December 31, 2019, when the Company had revenues of \$1,094,821. Our gross margin was 56.88% in fiscal year 2020, compared to 60.73% in 2019.
- *Assets.* As of December 31, 2020, the Company had total assets of \$802,777, including \$704,953 in cash. As of December 31, 2019, the Company had \$416,779 in total assets, including \$290,842 in cash.
- *Net Income.* The Company has had net income of \$145,964 and net losses of \$78,915 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future other than the profits of the business.

We will likely require additional financing in excess of the proceeds from the Offering in the future in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering and the profits from the business. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. The Company intends to raise additional capital in the future from investors. Runway & Short/Mid Term Expenses

Voyage Media, Inc. cash in hand is \$815,000, as of October 2021. Over the last three months, revenues have averaged \$225,000/month, cost of goods sold has averaged \$107,000/month, and operational expenses have averaged \$90,000/month, for an average net margin of \$28,000 per month. We are currently profitable.

Since the date our financials cover, revenue has continued to explode at Voyage. Our community is growing exponentially and our new podcast audience is growing in 10s of thousands every month. Revenue from our new podcast division and production fees and are in the mid 6 figures in only a few short months, and on pace to beat our own expectations. Our expenses have also gone up due to increasing our team head count and also preparing for this fundraise.

While forward looking statements cannot be guaranteed, the first 6 months of 2021 indicate we are on pace to grow 100% and maintain profitability over the next 3-6 months.
